For C, fruit ripening with CO₂ (Section 105.6.13) requires a permit only for specific flammable gases, not CO₂ alone, which is nonflammable. For D, organic coating production (Section 105.6.33) requires a permit only above 1 gallon per day, but 2 gallons is still small-scale and context-dependent-lumber storage is the clearer permit trigger here. Thus, A is the best answer.
