Options C and D are incorrect because Annex A and ISO/IEC 27002 are reference sets, not the sole sources of controls - organizations can design their own. Criteria for performing risk assessments (B) are part of 6.1.2 (risk assessment process), not risk treatment.

Thus, the correct requirement is A: Criteria for accepting identified risks.

ISO/IEC 27001 Clause 9.2 and 9.3 address internal audit and management review, but the determination of certification audit days is outside the organization's control; it rests solely with the accredited Certification Body auditors. Thus, answer: B is correct, as the CB's external auditor formally calculates and assigns the audit time.
