

Option A falsely assumes business analysts don't engage in test design, while in practice, they collaborate closely with testers. Option B incorrectly suggests that IQBBA and ISTQB lifecycles are mutually exclusive. In fact, they complement each other. Option C is incorrect in sequencing.
