What is a vitek hearing? - ANS A signed waiver of a due process hearing for voluntary cases or certification of a due process hearing for involuntary cases. Inmates who are considered for DMH transfer shall be advised of their rights to a hearing regarding the transfer. If the inmate does not waive their right to the hearing the following requirements shall be met. The inmate shall be provided written notice of a hearing to determine their involuntary placement in State Hospital/DMH.
