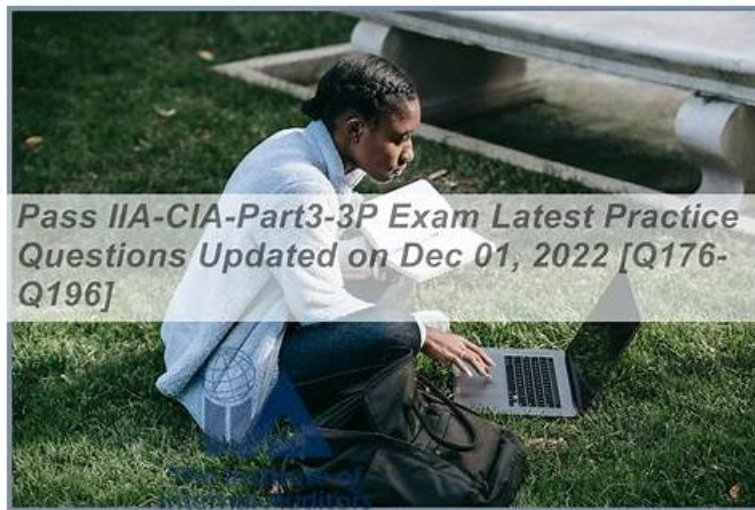

Because balance sheet amounts are expressed in terms of money, historical cost amounts for different periods are measured in units representing different levels of purchasing power. Profit or loss is also distorted because of inflation's impact on depreciation expense and inventory costs. Inflation therefore impairs the comparability of financial statement items, whether for the same entity overtime or for entities of differing ages. Presented below are partial year-end financial statement data for entities A and B.
