

Amazon Inspector automatically assesses applications for exposure, vulnerabilities, and deviations from best practices. However, Amazon Inspector does not provide a web application firewall service that can block malicious web requests³. Amazon GuardDuty is a threat detection service that continuously monitors for malicious activity and unauthorized behavior to protect your AWS accounts, workloads, and data stored in Amazon S3. Amazon GuardDuty analyzes and processes the following data sources: VPC Flow Logs, AWS CloudTrail event logs, and DNS logs. However, Amazon GuardDuty does not provide a web application firewall service that can block malicious web requests⁴.

Amazon CloudWatch is a monitoring and observability service that provides data and actionable insights to monitor your applications, respond to system-wide performance changes, optimize resource utilization, and get a unified view of operational health. Amazon CloudWatch collects monitoring and operational data in the form of logs, metrics, and events, and visualizes it using automated dashboards, alarms, and notifications.

However, Amazon CloudWatch does not provide a web application firewall service that can block malicious web requests.
