

The goal is to ensure that all parties engaged in work under the organization's control understand their security responsibilities before, during, and after employment or contract engagement.

Options A and B are too narrow, excluding key groups. Option C misrepresents the scope by implying a mutual responsibility but not identifying the individuals covered. The explicit scope includes employees, contractors, and third-party users.

Therefore, the correct answer is D.

Only after the scope is agreed does the Stage 1 audit begin, which reviews documented information and readiness. Stage

2 focuses on implementation and effectiveness. Evidence of corrective actions (C) is checked at Stage 2 if issues were identified earlier. Records provision (D) occurs during Stage 2, not first.
